Supplement Date: Dec 5 2022 4:49PM; Officer ID: 6748 - Sotelo, Marlene Montes; Narrative: On 11/21/22 I was asked to contact Wallace Dunn W/N/M DOB: [REDACTED], Tisha Crow W/N/F DOB: [REDACTED] and Denise Swanner W/N/F DOB: [REDACTED] who are current city council members and Odessa citizens. According to Dunn, Crow and Swanner they needed to report possible harassment from a subject identified as Matt S. Coday W/N/M DOB: [REDACTED]. Dunn explained that he was part of a committee that was created by Coday and his "oil company, to which only consisted of Dunn and Coday. According to Dunn, he soon realized that not only was he the only person on the committee but the "oil company" was a fake oil company. Dunn advised that he then quit the committee and slowly backed away from Coday due to Coday's increasing crazy and erratic behavior. When asked what type of behavior, Dunn claims that Coday would show up to their council meeting and make comments about their political platform. Dunn continued to say that Coday has gone onto social media and "attacked" him along with Swanner and Crow. Dunn explained that Coday has posted lies about their politics and their standpoints even questioning their ability to do their job. When asked what type of lies, Dunn claims that Coday has accused him of misappropriating funds to selling personal information to people. According to Dunn, he is part of the hospital committee in which Coday thinks that he has violated HIPPA regulations and posted those thoughts on different social media platforms "smearing his name". When asked if he had any evidence of direct texts messages to his personal cellphone and or personal social media, to which Dunn advised that one day in February he received a threatening text from Coday that consisted of Coday threatening to physically harm him. I then asked if Coday continued to send messages, to which Dunn advised no because he blocked him and Coday stopped communicating with him. Dunn continued to say that since that message Coday has made up posts on social media making him look bad and even has damage him vehicle. When asked if he had proof, Dunn stated no but felt that it was Coday who did it. Dunn advised that since then he has ignored Coday and completely cut him off any social media plus communications, which since then Coday has gone on a rampage attacking him on public social media.

At this time, I asked Crow and Swanner if Coday had sent them threatening messages, to which both stated no. According to Crow and Swanner, Coday has also "smeared" them both on social media making up lies about their political views. Swanner and Crow both advised that they really don't pay any attention to Coday and have ignored his comments on social media, which again Coday has gone on to attack them both. Crow continued to say that on Tuesday 11/15/22 she noticed a white F-250 barring [REDACTED] LP: [REDACTED] with the lights on parked on the road in front of her residence. Crow explained that she got the LP and ran it through her insurance computer (which she sells) and got the register owner Matt Coday. Crow stated that she knew that Coday was simply trying to scare her, to which it did not. Swanner advised that on the same day 11/15/22 during the day she noticed the same vehicle parked on the road turned on waiting. When asked if Coday got out of the vehicle and approached the front door, or look into the windows, to which both Swanner and Crow stated no. I then asked if Coday left anything on their porch or damaged anything on their property, to which both stated no. I then asked if Coday approached them or threatened them in any way, to which both again said no. When asked if they have seen Coday follow them to work, or to the store or while out on family outings, to which both stated they didn't think so but were not sure. By this time, Crow advised that she was not scared of Coday and that she was more upset about the social media posts which are complete lies and as Crow was continuing to tell me more, Dunn then interrupted Crow advising that they needed to be afraid of Coday claiming that Coday is crazy and possibly violent.

At this point, I explained that I agreed with Dunn to not discard Coday thinking that he won't do anything because you never know what a person will do. However, I explained that from someone looking out I observe a man that likes the notoriety of knowing people with political power and loves being part of the political world which may give him some notoriety. I continued to say that I didn't think that Coday was crazy only because he has stopped himself from breaking the law in trying to intimidate them which a crazy person would not know or care to stop. I advised that it appeared that he was loosing his notoriety by everyone ignoring him and felt that going on social media would give him back that sense of power by smearing them, in which they all agreed. I then asked what they needed me to do, to which Dunn, Crow and Swanner advised they simply wanted to make sure it was documented and nothing else. I advised all parties that this will be documented and I further instructed to

start recording Coday if they see him near them and or following them. I explained that the more evidence we have the better the case we will have, to which all three agreed. I then thanked Dunn, Crow and Swanner for their time and terminated the contact. This contact was recorded with my Axon Body Camera and uploaded to Evidence.com. Nothing further.

Supplement Date: Dec 14 2022 4:31PM; Officer ID: 6748 - Sotelo, Marlene Montes; Narrative: On 12/14/22 I was advised by my supervisor that Denise Swanner W/N/F DOB: [REDACTED] complained that I had not been able to contact me after multiple calls and voicemails. Upon reviewing my voicemails, it was revealed that I never received any voicemails nor phone calls from Swanner at any point, looking back from 11/22/22. On 11/22/22 I did receive a voicemail from the other reporting party Tisha Crow W/N/F DOB: [REDACTED] that consisted of Crow asking for me to show up during their meeting because the subject Matt S. Coday W/N/M DOB: [REDACTED] showing up at their Counsel Meeting and threatening to confronting them about their job performance. That voicemail was submitted into Evidence.com.

On 12/14/22 I then contacted Swanner to the number she provided on 11/21/22, to which she did not answer. I left a voicemail requesting Swanner to call me back. Moments later, I received a call from Swanner needing to add to the information report from November. According to Swanner, she observed Coday following her after she pulled into her garage. Swanner explained that she didn't notice anything until her grandson asked why that man in the white truck was flipping her off. Swanner stated that once she looked up she observed Coday's vehicle driving down the street but could not identify if it was Coday. Swanner continued to say that she was not able to obtain any evidence to substantiate her claims due to not being aware of Coday following her and because she was with her grandson. At this point, I asked Swanner if Coday tried to run her off the road or did anything, to which Swanner stated no. When asked if she noticed when Coday began to follow her, Swanner stated she didn't know when he did. Swanner then advised that she looked up Coday on social media and showed her grandson a photo of him, to which her grandson stated that was the same man that was following them and flipped them off. Swanner then advised that her grandson then disclosed that he and his friends have seen Coday drive by Swanner's residence on several other occasions even stated to Swanner that he felt that Coday did not belong in their neighborhood. According to Swanner, she needed to reach out to me only to report this incident for documentation purposes. I then explained to Swanner that if she does happen to catch Coday following she needed to have proof and have positive identification of Coday being in that vehicle not just seeing his vehicle, to which Swanner advised she understood. Swanner then stated that she was needing to document this incident, just in case. Swanner was thanked for her time and the phone call was terminated. This recording was tagged into evidence and attached to this report.

On 02/06/23 I received a call from Swanner advising that she had a friend who was currently being "attacked" by Coday through social media. Swanner then handed her cellphone to a subject that identified himself as Christopher Cody Gonzalez W/H/M DOB: [REDACTED]. According to Gonzalez, Coday has been harassing him since March of 2022 through social media. I then asked Gonzalez if he had screen shots of the messages, to which he stated he did (see case# 23-0001543) for further. Gonzalez then handed the phone over to Swanner who advised that she has several more screen shots where Coday is continuing to "harass" her. I then advised Swanner that I will send her links to Evidence.com and asked her to upload what she had. Swanner was thanked for her time and the phone call was terminated. On 02/07/2023 Swanner uploaded 13 screen shots which consisted of Coday's FB page posting his opinions about the City Council including Swanner. Once again these posts are on a public forum nothing criminal. Narrative complete.
